 - f) **Local Status Certificate (FORM-III)(as per G.O.Ms.No.132 & 133, GA (SPF&MC)Department, dt. 13.06.2016 and Circular Memo No.4136/SPF&MC/2015-5, Dt: 08.08.2016 & Memo No.4136/SPF&MC/2015-9, dt:03.09.2016) issued by Tahsildar, if migrated to Andhra Pradesh.**
 - g) **Hall-Ticket issued for written examination.**
 - h) **One set of attested copies of all the above certificates.**
